1) Call to order

Demaris "Dee" Siconolfi thanked all for coming and meeting was called to order at 9:04 am.

Thank you to Herb for hosting our meeting. A basket was passed for appreciation tip. Dee shared the long history of SAWGA, which was established in 1948, making it 74 years old. We must preserve this wonderful organization!

Members are asked to stand, state their name and club before making comments, and the names of those who make motions/seconds will be recorded. It will also help if members refrain from visiting during meeting discussions so that all can hear. SAWGA meetings will be recorded to assist Secretary in completing accurate minutes. This is all to make sure our meeting minutes are as complete and as accurate as possible.

5) Executive Board, Club Presidents, and Other SAWGA Members

Dee reminded all that the Junior and Senior Reps from each club make up the Executive Board. Reps are responsible for taking all information from the SAWGA meetings back to share with their club members, along with bringing questions and club opinions on issues back to SAWGA meetings.

6) Secretary's Report and Quorum

We have a Quorum (24 eligible to vote, 16 attendees equals a Quorum) with 23 Jr. and Sr. reps present.

Discussion on minutes from October 8, 2021:

Sue Lightfoot was unable to attend today, but sent an email to Dee with this correction: Currently the minutes state that in her speech Sue said she had communicated with the Guthrie family, but she actually stated that she was speaking on Suzi Stone's behalf. See attached email recording this correction.

MOTION - Sue Meyer moved to accept the corrected minutes for October 8, 2021. Seconded by Jan Smith.

Motion passed with 21 yea votes, and zero nay votes (by show of hands).

7) Treasurer's Report and Audit Report

2021 Year end Cash Balance is \$2593.15 after certificates were paid.
See attached Treasurer's Report, along with notes from Beth Wrigley.
There is a new projected budget to be discussed by end of meeting.
\$414.25 remaining from the city tournament will be put back into the tournament fund.
There are new membership forms for each club, and legacy member's information is already on the forms. There is room to update information and add new members.
Certificate forms are due by April 15th.

SWEEPS Certificates should be dated December 31st, even though Treasurer has until Jan 15th of the following year to complete the books. SAWGA is on a calendar year.

It was brought to the club's attention that Roberta Wisdom from Deer Park never received her \$95 certificate. Marlene Jensen had emailed Beth Wrigley inquiring for Roberta, and Beth has never re-issued the certificate. It was discussed that the protocol for missing certificates should be that certificates are immediately re-issued when there is no record that original certificate was redeemed.

MOTION - Doll Fitzgerald moved to re-issue the 2021 Certificate for \$95 (amt. to be confirmed) to Roberta Wisdom from Deer Park.

Seconded by Coco Spurway.

Motion passed with 23 yea written votes, and zero nay votes.

Audit Report

SAWGA books were audited by Beth Wrigley's and Bobbi Jo Rathvron's husbands, and were found to be in good standing. They did recommend that the officers and/or executive board should meet more often, and deal with issues as they arise. There was discussion that some feel uncomfortable with the protocol that the treasurer's husband completes the audit, even though they did a great job. For the sake of all involved, it was recommended that the audit be completed by qualified members of SAWGA. There are members of SAWGA who have CPA/accounting backgrounds, and Darcia Waples and Teri Zollinger both have volunteered to help with audits.

Audit Report continued

MOTION - Terry Zollinger moved that going forward the Treasurer's books will be audited by qualified SAWGA members in good standing. Rae Sapp seconded.

Discussion: Leslie Sevigney pointed out that the Treasurer's Duties states that an audit needs to be completed, and doesn't specify by whom. This is a way to put the audit protocol into all future treasurer's duties.

Who will appoint and approve auditors?

Previous motion on the floor is dead for the following amended motion:

AMENDED MOTION - Lori Walker moved that the SAWGA books will be audited by two qualified SAWGA members in good standing who will be selected by the President at the Fall meeting. The audit will be conducted and reported on at the Spring meeting.

Seconded by Linda Metcalfe. **Motion passed** with 23 written yea votes, zero nay votes.

8) Unfinished Business

Thank you to **Jackie Babin** for updating all of the 2022 forms, and **thank you** to **Sue Lightfoot** for uploading all to the SAWGA Website. This is a huge job! Future needed corrections should be sent to Jackie Babin via text or email. Please make sure names, phone numbers, and email addresses are correct before you send to Jackie.

Leslie Sevigney, Parliamentarian review/history:

Motions - repeating motions, identifying who has made/seconded motion is very important.

The Jr. and Sr. Reps for each club makes up the Executive Board. Twelve clubs with two reps equals 24 votes.

There was a Zoom officers meeting yesterday. It was discussed that the meeting protocol needs to be more specific so that the recorded minutes are more complete and accurate.

Leslie suggests these changes to meeting protocol:

-Attendees will sign in as they arrive. There will be a form for Jr. and Sr. Reps, and one for Presidents and Guests. It will be established at the beginning of the meeting whether or not we have a Quorum, which is sixteen executive board members present out of the possible twenty-four.

-Voting will happen by written ballot.

-Motions can be made only by Executive Board members, and minutes will reflect who made and seconded the motions. Motions should be restated before votes taken.

-The number of yea/nay votes will be recorded in minutes.

Meeting Protocol Changes cont

-Motions will pertain only to one single issue.

-Jr. and Sr. Reps should be taking ongoing or tabled issues back to their clubs, share the information, and get a sense of what those clubs think about these issues so that they can come back and vote accordingly.

Example: Proposals for any fee/dues changes should be presented to clubs by the reps so that they can share the feedback with the executive board. Thank you for this education, Leslie!

SAWGA Club Flags

There was discussion about the need for a new flag for Latah Creek. We need to find out what the cost is for new flags, and what businesses might be available to make them for us.

Kathy Skrabak suggested this issue be **tabled** until Fall meeting when we have more information.

Laura Bossart Award

Previously tabled, this award is to recognize outstanding contributions by SAWGA members, past or present, to the women's golf community. Should it be brought back? Questions that members have:

What is the criteria for each club to make their nomination? Is it for life time contribution or based on current year? How "great" does member have to be to receive?? In the past, nominations were made by past recipients??

It was brought up that not once have there been twelve nominations (one from each club) Jackie Babin stated that Sue Lightfoot is willing to hep with award.

Doll Fitzgerald suggested that reps discuss with each club, and email Dee with club responses regarding the Laura Bossart Award. Emails should be sent to Dee by May 1st. This should be enough time after clubs have had their first meeting. Reps need to put this on the agenda for first club meeting.

Connie Guthrie Perpetual Trophy

Previously tabled, there remain many questions regarding the history of Beth Wrigley replacing the original Connie Guthrie Perpetual Trophy with a new one, and keeping the original trophy in her possession. It was never voted on, and there is no approved motion in any previous minutes regarding Beth Wrigley permanently keeping the original Connie Guthrie Perpetual Trophy.

Demaris read the letter from Suzi Stone dated March 1, 2022 regarding retiring the Connie Guthrie Perpetual Trophy (copy attached to these minutes). Suzi Stone is a past 4 time recipient, and Dee shared the history of Connie's 16 wins over a span of 29 years. She is an amazing woman and golfer, and Dee would like to invite both Connie and Suzi to our SAWGA luncheon.

This is what has taken place:

Beth Wrigley purchased a new trophy with her own funds. She only did this because she thought she was keeping the original trophy.

The original trophy has one remaining space available for a recipient, and there was discussion whether the trophy could be refurbished.

Connie Guthrie Perpetual Trophy cont

Last year's recipient, Karen Madison from Qualchan, is aware that there is one space remaining, and would like her name added to the original trophy.

What some members remember from the October, 2018 meeting is that Beth stated what was going to happen, and most were "dumbfounded". The minutes from that meeting state that there will soon be no more room on the trophy, and any other discussion is unclear.

There has been previous discussion about keeping the original trophy at the Spokane Memorial Arena in the Spokane Sports Hall of Fame, and opinions vary about that idea.

Beth stated at a Zoom officer meeting yesterday that she would have never paid for a new trophy if she was not able to keep the original.

The new trophy is currently at Qualchan, and is called the Beth Wrigley SAWGA Championship Trophy.

In the past, recipients have received a small trophy that they may keep.

Questions -

- Can original trophy be refurbished?
- Could a pedestal be added for additional name plates?
- Could new trophy be modified and renamed?

Discussion took place to reimburse Beth Wrigley for the purchase of the new trophy.

MOTION - Kathy Skrabak moved that President Demaris Siconolfi collect both trophies and take them to a trophy shop for evaluation and estimates to refurbish and add space to the Connie Guthrie Perpetual Trophy, and possibly make changes to the new trophy.

Seconded by Jan Smith.

Discussion: Leslie Sevigney confirmed that it is possible to bring up this subject again, and rescind the previous motion. We are looking at the facts, because as she read in the previous minutes, we really don't have answers for this. **Motion passed** with 22 yea written votes, zero nay votes.

Additional meeting was called by President Demaris Siconolfi for Friday, June **10th**, **2022**, **9:00** am, Wandermere, to discuss evaluation/estimates of both trophies, and take action to resolve issue.

9) Standing Chair Reports

No reports for SWEEPS 1-3 and 4-6

Numerica Cup - Jackie Babin

The question has been asked if the schedule could be made so that players need not play the same groups twice, and play the home team once. Jackie worked the schedule and made it happen.

Jackie will send PDF to Sr. Reps on Mondays.

Vickie Kelly shared that per Steve Conner, there may still be some irrigation issues at Downriver into the summer, which could mean some "ground under repair". Players will be made aware of areas before starting play.

SAWGA Scramble - Sue Meyer

June 17th at MeadowWood - Carts are now \$19/rider Greens fees down \$1 Entry fee \$10

Question came up regarding scramble rules - Rae Sapp experienced playing as a 3some because one player was unexpectedly absent. They should be able to alternate one extra shot if alternate player is not available.

SAWGA Championship - Dianne Quast

See attached tournament executive board meeting report. There is a three tier program for donor sponsors. Dianne reminded us that donated items may be brought to the banquet. Tournament fee same as last year. Sept 6 - Kalispel, Sept 7 - Deer Park, Sept 8 - Downriver

Banquet will be Sept 30th - mid day, \$35/person, Ruby River Hotel Dianne asked if sponsorship letter could be emailed to all club presidents to be shared with their clubs, and also if Sue Lightfoot would post on the website(must be PDF). The more sponsors the better!

Dee shared that she could not be happier with the Downriver Tournament Committee

10) New Business

Thank you to new locations to replace Fairways 2022 tournaments:Downriver - SWEEPS 1-3Tues, July 12thDeer Park - ChampionshipWed, Sept 7th

Over/Under Fund

Previously approved at Fall 2021 meeting, new discussion regarding the \$50 fee to each club for a fund to cover monetary changes in tournament participation, discrepancies, and necessary corrections. It was stated that the treasurer should follow up with these issues as they come up, and that there is no need for such a fund, as this just creates more bookkeeping for the Treasurer.

MOTION- Jackie Babin moved that the \$50/yr per club fee for the Over/Under Fund be suspended for the year 2022. A report on the data for 2022 will be given at the March 2023 meeting, and further action will be decided at that time. Seconded by Lori Walker.

Motion passed with 22 written yea votes, zero nay votes.

Numerica Cup - Dee Siconolfi

Numerica Credit Union had previously given Dee a long term commitment to sponsor the Numerica Cup for \$2500/year. Due to re-organizing their departments, they have rescinded that commitment. After Dee met with many representatives, she was able to acquire a \$1500 commitment for this year, and any future sponsorship will be on a year to year basis.

The 2022 budget proposal reflects this new amount, and adjustments have been made for payouts.

Dee is asking if anyone has other corporate sponsorship possibilities in mind?

Thank you, Dee for all of the time and effort it took to keep the Numerica sponsorship!
